Other Grains

Maximum of 2% of other grains or soybeans allowable per load. Loads above 2% will be rejected.

Heat Damage

1 cent each 1/10 of 1% beginning at 2/10th of 1%

Maximum of 3%

If over 3% - Consult Commodities Manager

Infested: Corn is considered infested when found to contain two or more live weevils. Infestation is discounted at 10 cents per bushel.

Musty: 10 cents per bushel

Sour: 10 cents per bushel

Aflatoxin: Levels over 5 ppb (parts per billion) will be rejected. Fumonisin levels above 3 ppm will be rejected. Zearalenone levels above 100 ppb will be rejected.

POET Biorefining-Mitchell reserves the right to reject any corn that is found to be musty, heating, sour, or possessing a commercially objectionable foreign odor (COFO).

Corn is graded according to USDA standards.
